- 1 Question/Statement: Please provide a description of Item Number 18: GLOVES - RUBBER - SIZE X LARGE.

- 3 Question/Statement: What is the thickness requested for Item Number 51: PLASTIC BAGS 45X52 CLEAR HEXEN STAR SEAL 100 PER CASE BERRY PLASTICS or equivalent.
